	<ul style="list-style-type: none"> • The Committee agreed that this wasn't a tenable arrangement in the long term. • The Committee unanimously voted to adopt the iG method of collecting payments for competitions commencing in November. • PT will be communicating the new approach based on rationale prepared by SMc. However, he will be talking to Barry (BC) to better understand and communicate the small charge that is associated with the competition payment due to the use of Paypal. • Given impact on Winter League participation by players from the Ladies Section, PT will call Rogie to update her on the decision of the Men's Section. • Payments for Club 18-49 and 50+ competitions are unaffected by this decision. <p><u>Update from PT as @ 19th October:</u></p> <ul style="list-style-type: none"> • PT met with Barry to discuss the possibility of topping up your bar account and paying for competition from this account saving the admin fee being charged by PayPal. • BC looked into this option, but the Club Company only use the PayPal option for competition fees, it is not possible to top up from your bar account. • BC has organized a Zoom meeting with Tito who has been using the IG payment system for some time to answer any questions we might have this will take place on Tuesday 20th October. • BC has sent all captains a step by step user guide on topping up your IG competition account. PT asked for some changes and captains are all waiting for the final version. This communication will then be used by all sections to give a clear message to all on how the new system will work. 	PT
